# Working in Canada as a Student

#### What is a co-op work permit?

It is a paper document issued by IRCC to allow you to complete a work experience that is part of your studies.

#### Master of Financial Accountability Program

If you choose the internship option and enroll in **FACC6850**, you must have work authorization to do so, regardless whether the work is paid or unpaid. There are two ways you may obtain this work authorization.

The employer on your permit will be York University.

- All work must be approved by your co-op program office (hours, location, employer).
- You cannot use the co-op work permit for work that is not part of your co-op program.

#### **DID YOU KNOW?**

What IRCC calls a co-op can be called an internship, placement, practicum, etc. by York.



#### Temporary lifting of 20-hour per week cap on off-campus work

According to the <u>IRCC announcement on December 07, 2023</u>, some students may be eligible to work fulltime off-campus.

If IRCC received your study permit application (or extension) on or before October 7, 2022, from November 15, 2022, to April 30, 2024, you can work more than 20 hours per week off campus.

If IRCC received your study permit application (or extension) between October 8, 2022, and December 7, 2023, from January 1, 2024, you can work more than 20 hours per week off campus to April 30, 2024.

If IRCC received your application for a study permit extension after December 7, 2024, you need to stop working more than 20 hours per week without a work permit on the date the study permit you are applying to extend expires.

If your co-op placement ends after April 30, 2024, or if you aren't eligible for the temporary policy change, **you need to apply for a co-op work permit** to cover the period after that date.

# We recommend all students with a required work placement in their program apply for a co-op work permit.

#### Working off campus

You can work off-campus, without a work permit, if you meet **all** of these requirements:

- you have a valid study permit that includes a condition that says you can work off-campus
- you're a full-time student at a <u>designated learning institution</u> (DLI)
- you're enrolled in a postsecondary <u>academic</u>, <u>vocational</u> or <u>professional</u> <u>training</u> program
- you've started studying
- your study program
  - is at least 6 months long, and
  - leads to a degree, diploma or certificate
- > you have a Social Insurance Number (SIN)



# Can I work off-campus while on co-op?

As long as you are eligible to work off-campus, the co-op work permit does not prevent you from this.



#### Working on campus

You can work on your school campus, without a work permit, if you:

- > are a **full-time** post-secondary student
- > have a valid study permit, and
- > have a Social Insurance Number (SIN).

# Can I work on campus while on co-op?

As long as you are eligible to work on-campus, the co-op work permit does not prevent you from this.



#### **QUICK FAQ**

#### WHEN WILL MY CO-OP WORK PERMIT EXPIRE?

The co-op work permit is usually issued for the same time as your study permit.

#### DO I NEED TO ALSO EXTEND MY STUDY PERMIT?

If your study permit is expiring soon (in the next 6 months), you can apply to extend your study permit at the same time as you apply for a co-op work permit.

# HOW MUCH DOES IT COST?

The co-op work permit is free.

If you are also applying for a study permit, you will need to pay for this.

#### HOW LONG WILL IT TAKE TO GET MY PERMIT?

Currently from inside Canada, the processing times are:

- Work permit only: 113 days
- Study permit extension: 77 days





#### Start an application

#### Apply to come to Canada

Includes applications for visitor visas, work and study permits, Express Entry and International Experience Canada. You will need your personal reference code if you have one.

#### Refugees: Apply for temporary health care benefits

Use this application if you are a protected person or refugee claimant who wants to apply for the Interim Federal Health Program.


#### Citizenship: Apply for a search or proof of citizenship

Use this application to apply for proof of citizenship (citizenship certificate) or to search citizenship records.

#### **Personal checklist**

#### Personal Reference Code

If you have already completed the Come to Canada or the Express Entry wizard, you would have received a document checklist and/or a personal reference code based on the answers you provided.



#### I do not have a Personal Reference Code

If you do not have a personal reference code, you may answer a series of questions to find out if you are eligible to apply for a visa and/or permit, apply for Express Entry, and begin an online application.

If you begin your application after you have logged into your account, you will not receive a personal reference code, as the system will save your document checklist right into your account.


#### **Temporary Resident Visa**

You will need a temporary resident visa to return to Canada.

If you are working or studying in Canada, your temporary resident visa may expire at the same time as your work or study permit. If your work or study permit is expiring soon, please renew your study or work permit first. Once your study or work permit is approved, you may apply for your temporary resident visa.

#### What about biometrics?

Biometrics for visas, study permits and work permits are valid for 10 years. If you are not sure if/when you've given them in the past, you can use the <u>biometrics check status tool</u>. Some people may be exempt from giving biometrics. <u>Check to see if you are exempt from giving biometrics</u>.

Steps if you must give biometrics:

- 1. Pay the \$85 fee with your application
- 2. Get an instruction letter
- 3. <u>Book an appointment</u> (select Service Canada Centres)
- 4. Give your biometrics



#### Quick tips on filling out the IMM forms

- > Only fields with \* are mandatory
- > UCI is on your study permit
- > Personal details:
  - Your status is student.
  - From [date you first got student status]
  - To [study permit expiry date]
- Contact information:
  - The mailing address is where your documents will be mailed. Make sure it is an address you are checking.
- > Coming into Canada:
  - Original is the first time you came to Canada
  - Most recent is the last time you entered Canada
- > Previous Employment:
  - If you haven't been employed, enter student as your current occupation. Only the first section is required.

#### I'm having issues!

#### I CAN'T LOGIN TO MY IRCC ACCOUNT!

If you are being looped back to the homepage instead of logging in, there are a few things you can try:

- 1. Try another browser
- 2. Clear cache and try again
- 3. Try another device

#### I CAN'T OPEN THE IMM FORM!

You need Abode Reader. If you do not have it, you can download it for free.

The forms cannot be opened in a browser. You must save them to your computer and then open the file from the location where you saved it.



# How to apply for a co-op work permit from outside Canada

#### IF YOUR STUDY PERMIT HAS EXPIRED/WILL SOON EXPIRE, AND YOU NEED A CO-OP WORK PERMIT

# You should apply for a new study permit and a co-op work permit simultaneously.

You can't submit a co-op work permit application separately from your study permit application if you're applying from outside Canada. You can use the <u>web form</u> to show you've been accepted into a program with a mandatory work component.



# Upload a copy of your **co-op work permit letter**.

Upload a **letter of enrolment**. <u>Not</u> your old letter of acceptance – that is only for new students.

# Write a **letter of explanation** and upload a **copy of your current study permit**.

You may also include any other relevant supporting documents here.

# For a study permit application, where do I get my letter of enrolment?

If you need a study permit extension, you must submit a letter of enrolment that shows enrolment beyond your study permit expiry date.

#### Do not submit your letter of acceptance since

you are a current student – this is only for new students.

You can get your letter of enrolment online here:

- > The standard online confirmation is fine
- After logging in to Passport York, make sure to choose the "detailed" version

#### Print My Verification of Enrolment and Registration Letter for Fall/Winter 2020-2021

The online service is only available to Undergraduate degree students only.

#### What to write in your letter of explanation

It is uncommon for current students to apply for a study permit from outside Canada. You want to be clear about your situation so IRCC can properly process your application. In your letter of explanation, write that:

- > you are applying for a study permit and a co-op work permit from outside Canada
- > you have a valid study permit, including the expiry date (attached)
- > you need [amount of time] to complete your studies and expect to graduate on [date]
- > you are requesting a study permit until the end of your program plus 90 days
- > you are also applying for a co-op work permit to participate in your co-op program
- > how you plan to afford your studies, including a budget
- > a list of supporting documentation you are including with your application



#### What other documents do I need?

Local visa offices may have specific requirements in terms of forms, types of financial support documentation they require, etc.

Make sure to check your local visa office for any specific requirements that they may have. <u>https://www.cic.gc.ca/english/information/applications/student.asp</u>

If there is not a specific section in the document checklist to include these, you can upload them under client information.
